

# **JUDGING PROCESS**

How the awards were won

Entries for the UK Health and Protection Awards 2022 were divided into two categories comprising a total of 31 awards - those from advisers and intermediaries, and those from insurers and other service providers.

## **PROVIDER AWARDS**

The insurer and provider categories were put to a public vote for readers of Health & Protection to choose those companies which performed best in their respective markets over the previous year.

Thousands of votes were received from advisers and intermediaries, with the top performers in each category being whittled down to form the shortlists.

Each provider was then invited to submit an entry for each category they were shortlisted in against a set of key criteria.

The independent judging panels, chosen for their insight and expertise, then reviewed, assessed and vigorously debated the entries in each category to decide the ultimate winners.

## **ADVISER AWARDS**

The adviser awards were open to entries from any advisers, intermediaries or broker firms operating in the relevant UK or international categories.

This year saw four new categories introduced for intermediary awards - to recognise the best small advice firms operating in each of the health and protection sectors, and for the best individual adviser in each sector.

More submissions are including testimonials which is great to see and arguably a vital element of any award entry, demonstrating the impact individuals and organisations are having on customers. After deciding on our winners, it was lovely to see them collect their awards at what was a fabulous evening event. The room was packed full of guests celebrating successes across the health and protection market. Huge congratulations to the winners and all those shortlisted.

After breaking into the industry in the early 1980s Ian Smart spent a decade learning the ropes across a wide variety of specialisms before moving to Royal London. He has since played a key role in the UK protection industry's evolution for the last 27 years, including launching specialist protection insurer Bright Grey in the early 2000s.

He was one half of the team that formulated the first relevant life plan and kicked off much of the modern business protection market.

He helped lead the charge to introduce the beneficiary nomination process and his support to advisers with detailed technical questions has become indispensable. Having retired in the summer he will be sorely missed.
